#### 收集個人資料聲明

Your personal data we collect may be used for following purposes:

- providing insurance products and services to you and processing requests made by you in relation to our insurance products and services, including but not limited to requests for addition, alteration or deletion of insurance benefits or insured members, process requests for payments as well as cancellation, renewal, or reinstatement of insurance policies;
- (iii) managing, processing and defending insurance claims as well as conducting any incidental investigation, and exercise the Company's rights including but not limited to subrogation right;
- (iv) performing functions and activities incidental to provision of insurance products and services such as identity verification, date matching and reinsurance arrangement; exercising the Company's right in connection with the provision of insurance products and services to you from time to time, for example, to recover
- indebtedness from you,
- designing insurance products and services with a view to improving the Company's services;
- (vii) preparing statistics or use of accounting, actuarial and conducting research; (viii) marketing services, products and direct marketing; (ix) meeting the disclosure requirements of any local or foreign law, regulations, codes or guidelines binding on the Company and/or its group and conduct
- matching procedures where necessary;
